Area youth of all ages are invited to have fun and get muddy at The Alliance of Southwest Missouri's annual Mudstock, taking place on Saturday, June 29<sup>th</sup> in Carthage at Myers Park (behind Lowe's – follow the Mudstock signs). The event will be held from noon to 3:00 p.m. and is free of charge to the public. In order for children to participate, permission forms must be completed by the child's parent/guardian. For children age 12 and under, the parent/guardian must also remain on Mudstock grounds during the event.

As the name implies, Mudstock is a mud-filled event featuring a mud pit, and multiple water features, all designed by the Carthage Fire Department, Carthage Police Department, and the Carthage Caring Communities Coalition.

Mudstock is a fun, interactive alternative to drugs and alcohol that promotes getting muddy on the outside while staying clean on the inside. Sunscreen, shorts, shirts, socks, and shoes are required (NO SANDALS ALLOWED - NO EXCEPTIONS).

IN CONSIDERATION of being permitted to compete, officiate, work for, volunteer for, or participate in any way in the EVENT(S) EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she knows participating in this event, or volunteering for this event, may result in serious injury, accident, or death. Each of the undersigned assumes all risks associated with participating and or volunteering in this event including but not limited to: falls, contact with other participants, the effects of the weather, including high heat and/or humidity, traffic and the conditions of the course, all such risks being known and appreciated. The Undersigned warrants and represent that BEFORE participating in this EVENT I have made my own determination with a medical provider of my choosing that I am medically able, properly trained, physically fit and capable of participating in this event, and that my medical care provider has approved my participation.

2. HEREBY RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE any promoters, organizers, instructors, trainers, volunteers, supervisors, or parents, other participants, employees, or any agent thereof, officials, referees, rescue personnel, owners and lessees of premises used to conduct EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others, including but not limited to The Alliance, City of Carthage, all sponsors and anyone or entity who provide any equipment, promotion, medical care, give recommendations, directions, regulate traffic, referee, or officiate, or call or fail to call the event or give warnings of adverse weather or instructions or engage in any EVENT- related activities; all of whom are referred to as "Releasees", FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY NEGLIGENCE OF THE RELEASEES OR OTHERWISE, including those claims which may arise from any alleged negligence of any Release or concurrent negligence of a Release and any other person or entity.

HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) and HEREBY acknowledges **THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH** and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
